This pertains to your Memorandum dated January 28, 2022 regarding the abovementioned subject.

Please be informed that the concern of Mr. Pedrito Nepomuceno was mistakenly referred to this Office for action wherein the cited incident of Food Delivery Truck with Plate No. CAY-9934 allegedly carrying illegally sourced lumbers happened in Barangay Tigatto, Davao City and not in the Province of Marinduque.

It can be recalled that we have replied already on the matter through email message dated August 20, 2021 with attached screen shots of various Facebook posts and comments. In fact, the DENR Aksyon Kalikasan acknowledged our email response and commented that the issue is considered **RESOLVED**. Likewise, on August 20, 2021 Mr. Nepomuceno, the complainant clarified that the incident did not happen in Marinduque (Please see attached screenshot of his email).
