In compliance with your Memorandum¹ dated January 20, 2022 regarding the application for Gratuitous Special Use Permit (GSUP) on the upgrading of Farm to Market Road (FMR) and construction of bridge to be funded through the Department of Agriculture – Philippine Rural Development Project (DA-PRDP) at Barangay Manoot, Rizal, Occidental Mindoro, submitting herewith are the following lacking requirements, to wit:

- Certified True Copy of Letter of Intent to apply GSUP dated July 16, 2021;
- 2. Certified True Copy of the Official Receipt No. 7261427F dated October 4, 2021;
- 3. Certified True Copy of Certification of land classification status of the area;
- 4. Certified True Copy of appropriate Certification from the National Commission on Indigenous Peoples (NCIP);
- 5. Certified True Copy of Indicative Management Plan (IMP) including the budget allocation for the development and management of the projects;
- Certified True Copy of Resolution No. 2021-66 authorizing Hon. Ernesto C. Pablo, Jr., Municipal Mayor of Rizal, Occidental Mindoro to apply for GSUP; and
- 7. Re-plotted map with Technical Description that will cover an approximate area of 3.0402 hectares (3,800 meters by 8 meters) and the corresponding shapefile has already been sent to fmb@denr.gov.ph.

Furthermore, relative to the ongoing dispute between the Provincial Local Government Unit (PLGU) of Occidental Mindoro and Municipal Local Government Unit (MLGU) of Rizal, Occidental Mindoro, it was mentioned in the attached letter² dated February 2, 2022 from Antonio G. Gerundio, *CESO III, DPA*, Regional

Executive Director, MIMAROPA Regional Project Coordination Office, Philippine Rural Development Project, Department of Agriculture, that either of the two (2) LGU's are entitled to implement the said subproject subject to their compliances of the requisite of the PRDP on first come first serve basis. Likewise, the PRDP has suggested that this Office may issue the GSUP to whomever complies with the department's requisite documents first.

Below is the tabulation of the accomplished requirement of the concerned LGUs, to wit;
