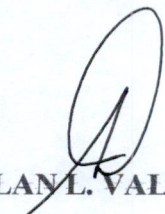

As such, all PENROs and CENROs shall submit the name of their respective Information Officers to the SCIS, and corresponding Order shall be issued related to this.

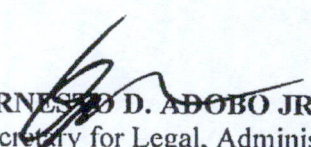
