This refers to the conduct of Forest Land Use Planning (FLUP) of the Local Government Units (LGUs) in relation to the DENR-DILG Joint Memorandum Circular Nos. 1998-01 and 2003-01 which provides the Guidelines on the devolved Forest Management Functions. A series of Orientation Meetings, Consultations and Workshops were held for the Enhancement of FMB Technical Bulletin No. 2 on FLUP and currently on its series of presentation/discussion and defense to the Policy Review Committee of the Forest Management Bureau (FMB).

During the 1st quarter of 2019, a workshop on the Universe and Baseline Database on Forestry Tenure Instruments, Programs and Projects was held and one of the activities essential for the completeness and updating of forestry sector data is the LGUs FLUP that will serve as venue for future planning and integration of the same to the LGUs CLUPs.
