

This refers to your Memorandum dated September 29, 2020 requesting land classification confirmation of lot Nos. 2216, 2217, 2218, 2219 and 2220 of Cad 862-D for processing and issuance of Residential and Agricultural Free Patent located in Barangay Rizal, Roxas, Palawan.

Please be informed that this Office, upon careful verification, found out that there are inconsistencies on the submitted data. Lot 515 of PLS 798 is equivalent to Lot 2311 of Cad 862-D covering CSD-04-032019-D (please see attached letter from Merling Lagan). This lot area falls within Alienable and Disposable land as per LC Map No. 2419, Project 1-A, Block I certified dated December 22, 1960. Therefore, this Office cannot provide the said request.

Relative hereto, we appreciate your effort on submitting lot data computation and vicinity map of the potential lot. However, you are hereby instructed to submit Technical Description and Sketch Map of the potential lots as it is the requirement of this Office for venification and kindly submit your certification based on said Technical Bulletin for future submission.
