MUNICIPAL RESOLUTION NO. 253

APPROVING RESOLUTION NO. 21 SERIES OF 2021 OF BARANGAY SAN NICOLAS: "A RESOLUTION APPROVING THE CONSTRUCTION OF INTAKE STRUCTURE IN SITIO PINAGKULUNGAN, BARANGAY SAN NICOLAS, CORON, PALAWAN, PURCHASED A PRIVATE LOT OF LATE MR. VILLARINO CELEDONIO UNDER THE SUSTAINABLE PROJECT OF NATIONAL HOUSING AUTHORITY (NHA) FOR YOLANDA VICTIM OF CORON AREA WITH COORDINATION OF OTHER RELEVANT GOVERNMENT AGENCIES TO CONSTRUCT AND OPERATE THE PROJECT IN SAN NICOLAS AREA."

WHEREAS, when the island municipality of Coron was hit by super typhoon Yolanda in 2013, many residents were left homeless and their means of livelihood were badly affected causing devastation to the lives of the typhoon victims especially in marginalized communities;

WHEREAS, with the drive to help the people to rise above these difficult times, several recovery programs and projects were initiated by various government and non-government agencies in the locality and one of them is the housing project being implemented on a purchased parcel of lot by the National Housing Authority (NHA) in Barangay San Nicolas;

WHEREAS, with the commitment of NHA to provide shelter to the affected families, the construction of more than two thousand units is implemented in the aforementioned barangay through this comprehensive and integrated housing program;

WHEREAS, this August Body deemed it necessary to confirm and support the above-stated barangay resolution for the realization of this sustainable project that will benefit the constituents of Coron;


NOW THEREFORE, on motion of the Honorable Ma. Aurora Riceli D. Balbutan, SB Member, and unanimously seconded by all Members present, be it,

RESOLVED AS IT IS HEREBY RESOLVED, approving Resolution No. 21 series of 2021 of Barangay San Nicolas: "A resolution approving the construction of intake structure in Sitio Pinagkulungan, Barangay San Nicolas, Coron, Palawan, purchased a private lot of late Mr. Villarino Celedonio under the sustainable project of National Housing Authority (NHA) for Yolanda victim of Coron area with coordination of other relevant government agencies to construct and operate the project in San Nicolas area.";


