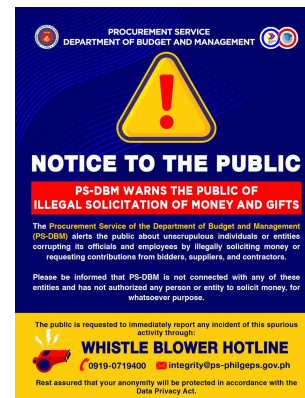

We would like to inform you that PhilGEPS will be conducting the **Trainer's Training Refresher Course** for the **Modernized PhilGEPS (mPhilGEPS)**. We will provide an update to the following functionalities: Annual Procurement Plan, Purchase Request, eBidding, Award Notice, AMP Publication, and Contract Implementation modules. Functionalities for the Consulting services and Pre-bid conference will also be tackled.

This is also in relation to the approval of the eBidding guidelines, wherein the PhilGEPS is directed to oversee the training and capacity development interventions for the PEs, Observers, and bidders and to develop the appropriate mechanism to ensure the efficient and timely implementation of the mPhilGEPS.

We recognize that this activity will help us to fast-track our training program. We have to build connections with agencies advocating reforms in government which we have been doing since the implementation of the government electronic procurement system.

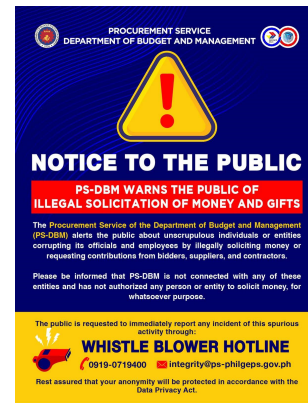
