Kindly specify also if there have been issues or concerns encountered in relation to securing of the FPIC as we will seek guidance from the National Commission for Indigenous Peoples as part of our Memorandum of Agreement with them.

In order to provide further guidance for the continuation of the activities for CY 2022, may we request submission of the report **on or before 23 March 2022**.
