

**RESOLUTION NO. 6620**

**EARNESTLY REQUESTING THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) REGIONAL OFFICE, THROUGH OIC-REGIONAL EXECUTIVE DIRECTOR LORMELYN E. CLAUDIO, CESO IV, TO FAST TRACK THE PROCEDURES IN THE ISSUANCE OF TREE CUTTING PERMIT FOR TREES ALONG THE NATIONAL HIGHWAYS IN THE MUNICIPALITY OF SAN JOSE, OCCIDENTAL MINDORO THAT ARE AFFECTED BY THE ROAD CONSTRUCTION OR WIDENING PROJECTS IMPLEMENTED BY THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH)**

**WHEREAS**, it has been years since the Department of Public Works and Highways (DPWH) implemented the nationwide road construction and widening projects which also include the national highways within the territorial jurisdiction of San Jose, Occidental Mindoro purposely to provide a more convenient, safe and reliable infrastructure facilities for the mobility of people, goods and services;

**WHEREAS**, such undertakings have certainly contributed to the economic progress of this municipality; on the other hand, numerous vehicular accidents resulting to deaths have also been reported since then and these are caused by the electric posts and uncut trees that remain within the right-of-way despite that roads and highways are completely constructed and widened already;

**WHEREAS**, in the previous years, this Sangguniang Bayan adopted resolutions respectively requesting the OMECO and DPWH to address such road obstruction concerns but no actions were taken yet due to certain procedures that said agencies have to go through, including the securing of Tree Cutting Permit from DENR;

**WHEREAS**, this Body learned that the DPWH has already submitted its application for Tree Cutting Permit with the DENR, but the long overdue request was not granted until this very moment. Taking too much delay in acting on the DPWH's request may further pose life-threatening risks;

**WHEREAS**, having the responsibility to promote the safety and welfare of its constituency, this Local Government Unit, through the headship of Municipal Mayor Romulo M. Festin, Vice Mayor Roderick Q. Agas and Sangguniang Bayan members intently request the DENR to expedite the procedures in the issuance of Tree Cutting Permit to DPWH to avoid possible accidents which may be brought about by the uncut trees along the national highways in this municipality that are affected by the road construction and widening projects of the latter;

**NOW THEREFORE, be it resolved to EARNESTLY REQUEST** the Department of Environment and Natural Resources (DENR) Regional Office, through OIC-Regional Executive Director Lormelyn E. Claudio, CESO IV, to fast track the procedures in the issuance of Tree Cutting Permit for trees along the national highways in the municipality of San Jose, Occidental Mindoro that are affected by the road construction or widening projects implemented by the Department of Public Works and Highways (DPWH).

**LET COPIES** of this resolution be sent promptly to the Office of the Mayor, DENR (MIMAROPA) Regional Office and to all concerned for information, guidance and appropriate action.
