By virtue of this deputation, they are authorized to assist in the enforcement of laws, rules governing environment, forestland, mineral lands, protected areas the notional parks, marine resources and sanctuaries) and other lands of the public domain under the jurisdiction of the DENR within their locality.

They are further authorized to perform the following

1 Assist in the issuance of apprehension receipts, seizure orders and notices of administrative hearings including the proceedings necessary for the conduct of the administrative adjudications of illegally procured, transported, owned/possessed and/or utilized forest products, wrighte (nor and tauna), minerals and other natural resources.

- 2 Arrest, even without warrant, any person who has committed or is committing in his/ner presence any of the offenses provided in environmental and natural resources laws, rules and regulations.
- 3. Deliver within the period prescribed by law from time of arrest and seizure, the offender including the apprehended natural resources products, tools/equipment and conveyances and coordinate with the appropriate official designated by law to conduct preliminary investigation prior to the filing of information in Court through the CENRO or PENRO or Regional Director, where it is most expediently available.
- Act as witness in Court for the speedy prosecution of criminal complaints against violators of environmental and natural resources laws, rules and regulations
- 5. Assist in the conduct of environment and natural resources information campaign, such as meetings, public assembly, and other extension activities within their areas of jurisdiction in coordination with DENR officers and personnel of other government or private agencies involved in similar work, and
- 6. Submit monthly accomplishment reports to the CENRO concerned or to the Field Operations Office having jurisdiction over their area of responsibility using the standard reporting form attached as "Annex 1"

They are authorized to exercise the power and authority conferred herein within the territorial jurisdiction of CENRO Coron, Palawan

This Deputation Order takes effect immediately and will expire after one (1) year from the date of approval unless sooner revoked or terminated by this Office.
