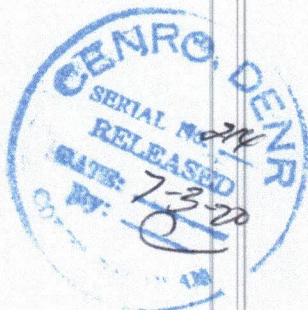
This is to reiterate the previous letter of Forester I Cristina J. Sabangan requesting for temporary reassignment to any DENR field office within Manila or Laguna area where her mother and her children currently live. An endorsement letter from this office released on February 27, 2020 has been forwarded to the PENR Office for review and consideration.


Please be informed that apart from her cited reasons to look after her aged mother and to look after her children, this Office was also made aware of a very personal issue which is causing emotional setback thus affecting her day to day life hence her request for temporary reassignment is significant in order to be apart from the subject person for her peace and emotional healing.

Further, her request was aggravated by the recent global pandemic which necessitate her need for immediate transfer since her mother is living all alone by herself at old age that needs constant supervision. And being currently assigned in Coron, Palawan makes it difficult for her to attend to her mother's need on a regular basis. The said location (Regional Office of Calabarzon) is 45 minutes away from their ancestral home which is the ideal location of re assignment given the current conditions due to the virus.

In view of the above, this Office interposes no objection on her appeal for temporary reassignment outside Calamianes until such time the pandemic and the tension in her personal issues subsides and pray that subject personnel be accommodated at the DENR-CALABARZON Regional Office.
