REQUEST FOR THE PARTRICIPATION OF THE PROTECTED AREA SUPERINTENDENTS (PASUS) AND CHIEF, CONSERVATION AND DEVELOPMENT DIVISION TO THE NATIONAL NIPAS REVIEW COMMITTEE-TECHNICAL WORKING GROUP MEETING ON JUNE 9,

2022

This is in reference to the proposed proclamation of Lower Agno Watershed Forest Reserve (LAWFR) in CAR, Ursula Island Game Refuge and Bird Sanctuary (UIGRBS) and Torrijos Watershed Forest Reserve (TWFR), in MIMAROPA Region and Liangan-Lipatan Mangrove Swamp Forest Reserve, Bagumbang-Malaubang Mangrove Swamp Forest Reserve, Malasag-Mahugunao Watershed Forest Reserve and Mt. Tago Range National Park in Region X as protected areas under the NIPAS.
