I. Introduction

For the 1st quarter of CY 2022, 21 Government Agencies reported the status of 289 projects amounting to ₱23.261 billion implemented in the MIMAROPA region. These agencies were as follows: Civil Aviation Authority of the Philippines (CAAP) Area Center 3, Department of Labor and Employment (DOLE), Department of Science and Technology (DOST), Department of Transportation (DOTr), Department of Public Works and Highways (DPWH), DPWH Marinduque District Engineering Office, DPWH Mindoro Oriental District Engineering Office, DPWH Palawan 3rd District Engineering Office, Department of Social Welfare Development (DSWD), Local Water Utilities Administration (LWUA), State College (MSC), Mindoro State Marinduque University (MinSU), National Housing Authority (NHA), National Power Corporation (NPC), Occidental Mindoro State College (OMSC), Provincial Government of Marinduque, Provincial Government of Occidental Mindoro, Philippines Ports Authority (PPA) - Port Management Office (PMO) Mindoro, Philippines Ports Authority (PPA)- Port Management Office (PMO) Palawan, Palawan State University (PSU), Romblon State University (RSU), and Western Philippine University (WPU).


These 289 projects generated a total employment of 9,350, of which 7,491 (80.1%) are male, and 1,859 (19.9%) are female.

Of the reported 289 projects, 41 projects or 14.19 percent were completed, 27 projects or 9.34 percent were on schedule, while 67 projects or 23.18 percent were ahead of schedule.

A total of 154 projects (53.29 percent) encountered problems in implementation with the following breakdown: DOTr – one project, DPWH – 61 projects, DPWH Marinduque DEO – 8 projects, DPWH Oriental Mindoro DEO – 8 projects, DPWH Palawan 3 DEO – 26 projects, LWUA – one project, MSC – two projects, MinSU – two projects, NHA – four projects, NPC – nine projects, OMSC – four projects, PG Occidental Mindoro – 16 projects, PPA PMO Palawan – two projects, PSU – nine projects, and WPU – one project.

Of the reported 289 projects, 283 (97.92 percent) were regular projects, 6 (2.08 percent) were rehabilitation and recovery projects (RRP) (Figure 1).

There were no Balik Probinsya, Bagong Pag-asa (BP2) and End Local Communist Armed Conflict (ELCAC) projects reported by implementing agencies for the first quarter of 2022.

This report also includes the highlights of the RPMC meeting for the first quarter of CY 2022 that was held on February 24, 2022 via Zoom videoconference.

II. Project Monitoring

A. Status of Priority Projects in MIMAROPA Region

Priority infrastructure projects contributed in the attainment of the outcomes of the Regional Development Plan 2017-2022. These projects have high impact to social and economic growth of the region.

1. RRP PAPs Implementation

To ensure full recovery and rehabilitation of calamity-stricken areas, the implementation of RRP projects were monitored.

a) National Housing Authority Region 4 (NHA Region 4)

As of March 31, 2022, NHA Region 4 reported implementing five RRP projects amounting to ₱1.035 billion (Table 1).

B. Status of Programs, Projects and Activities (PAPs)

1. Department of Public Works and Highways (DPWH) MIMAROPA

As of March 31, 2022, DPWH MIMAROPA reported implementing 68 projects funded under GAA 2020-2021 amounting to $\ref{p}6,940.92$ million (Figure 2). A total of two projects amounting to $\ref{p}197.43$ million were already completed, 61 projects amounting to $\ref{p}6423.49$ million encountered delays in implementation, one project amounting to $\ref{p}20$ million was on schedule, and four projects amounting to $\ref{p}300$ million were ahead of schedule.

2. DPWH Marinduque District Engineering Office (DEO)

DPWH Marinduque DEO reported implementing 40 projects amounting to ₱353.95 million. A total of five projects amounting to ₱61.50 million were already completed, eight projects amounting to ₱274.95 million encountered delays in implementation, and two projects amounting to ₱17.50 million were ahead of schedule (Figure 3).

3. DPWH Mindoro Oriental District Engineering Office (DEO)

DPWH Mindoro Oriental DEO reported implementing 39 projects amounting to ₱253.70 million. A total of seven projects amounting to ₱33.75 million were already completed, eight projects amounting to ₱56.90 million encountered delays in implementation, four projects amounting to ₱34.52 million were on schedule, and 20 projects amounting to ₱128.53 million were ahead of schedule. 


Figure 4. Cost of DPWH Oriental Mindoro DEO Projects by status of implementation, in millions

4. DPWH Palawan 3rd District Engineering Office (DEO)




Figure 5. Cost of DPWH Palawan 3 DEO Projects by status of implementation, in millions

DPWH Palawan 3rd DEO reported implementing 54 projects amounting to ₱635.79 million. A total of 12 projects amounting to ₱117.16 million were already completed, 26 projects amounting to ₱211.16 million encountered delays in implementation, and 16 projects amounting to ₱307.47 million were ahead of schedule (Figure 5).

5. Civil Aviation Authority of the Philippines (CAAP) Area Center 3

CAAP Area Center 3 reported one completed project amounting to ₱1.39 million for the first quarter of 2022.

6. Department of Transportation (DOTr)

The DOTr reported implementing one project amounting to ₱65.46 million. As of March 31, 2022, the average physical accomplishment of DOTr projects was 83.84 percent.

7. Local Water Utilities Administration (LWUA)

LWUA reported one project amounting to ₱25 million for the first quarter of 2022. The physical accomplishment of the LWUA project was 33.5 percent.

8. National Power Corporation (NPC)

NPC reported nine projects amounting to ₱1.4 billion for the first quarter of 2022. The average physical accomplishment of NPC projects was 82.74 percent with an average slippage of negative 16.11 percent.

9. Philippine Ports Authority (PPA) – Port Management Office (PMO) Mindoro

PPA PMO Mindoro reported six projects amounting to ₱1,902.28 million for the first quarter of 2022. The average physical accomplishment of PPA - PMO Mindoro projects was 40.40 percent with an average slippage of positive 23.50 percent.

10. Philippine Ports Authority (PPA) – Port Management Office (PMO) Palawan

PPA PMO Palawan reported two projects amounting to ₱47.74 million for the first quarter of 2022. The average physical accomplishment of PPA PMO Palawan projects was 68 percent with an average slippage of negative 0.90 percent.

11. Department of Labor and Employment (DOLE) MIMAROPA

DOLE MIMAROPA reported three projects amounting to ₱12.21 million for the first quarter of 2022. The average physical accomplishment of DOLE MIMAROPA projects was 48.77 percent.

12. Department of Science and Technology (DOST) MIMAROPA

DOST MIMAROPA submitted the status report on 19 projects amounting to ₱10.86 million. Six projects were already completed, ten projects were on schedule, and three projects were ahead of schedule.

13. Department of Social Welfare and Development (DSWD) MIMAROPA

DSWD MIMAROPA reported four projects amounting to ₱6,871 million for the first quarter of 2022.

Of the four reported projects, one project amounting to ₱5,215.60 million were completed and three projects amounting to ₱1,655.40 million

were on schedule.

14. National Housing Authority (NHA) Region 4

NHA Region 4 submitted status report of five projects amounting to ₱840.60 million. The average physical accomplishment of NHA projects was 24.74 percent with an average slippage of negative 10 percent.

15. Marinduque State College (MSC)

MSC submitted status reports on three projects amounting to ₱30.60 million. The average physical accomplishment of MSC projects was 96.67 percent with an average slippage of negative 1.40 percent.

Out of the three projects, two projects amounting to ₱14.07 million were behind schedule while one project amounting to ₱15.99 million was on schedule.

16. Mindoro State University (MinSU)

MinSU submitted status reports on two projects amounting to \$\mathbb{P}\$45.00 million. The average physical accomplishment of MinSU projects was 77.79 percent with an average slippage of negative 21.05 percent.

17. Occidental Mindoro State College (OMSC)

OMSC submitted status reports on eight projects amounting to \$\mathbb{P}\$57.54 million. The average physical accomplishment of MSC projects was 35.14 percent with an average slippage of negative 36.26 percent.

Out of the eight projects, two projects amounting to \$\mathbb{P}6\$ million were completed, four projects amounting to \$\mathbb{P}46.42\$ million were behind schedule, one project amounting to \$\mathbb{P}2.12\$ million was on schedule while one project amounting to \$\mathbb{P}3\$ million was ahead of schedule (Figure 5).



18. Palawan State University (PSU)

PSU reported the status of 16 projects amounting to ₱384.50 million for the first quarter of 2022.

Of the 16 reported projects, two projects amounting to ₱120 million was completed, nine projects amounting to ₱159.50 million were behind schedule, one project amounting to ₱35 million was on schedule, three projects amounting to ₱70 million were ahead of schedule. (Figure 7)

19. Rombion State University (RSU)

RSU reported the status of two completed projects amounting to ₱44.09 million for the first quarter of 2022

20. Western Philippines University (WPU)

WPU reported the status of three projects amounting to ₱80.44 million for the first quarter of 2022. The average physical accomplishment of WPU projects was 58.69 percent with a positive slippage of 0.35 percent.

21. Provincial Government of Occidental Mindoro

The Provincial Government of Occidental Mindoro reported the status of 28 projects amounting to ₱282.16 million for the first quarter of 2022.

Of the 28 reported projects, 16 projects amounting to ₱68.70 million were behind schedule, two projects amounting to ₱6.56 million were on schedule, while 10 projects amounting to ₱206.90 million were ahead of schedule (Figure 8).

III. RPMC Meeting

RPMC Co-Chairperson Ricky Sanchez, who is also Department of Budget and Management (DBM) MIMAROPA Regional Director, presided over the MIMAROPA RPMC meeting through zoom video conference on February 24, 2022.

RPMC Secretary Roy Dimayuga presented the MIMAROPA 2022 RPMC Work Program and the Monitoring and Evaluation (M&E) Plan for approval and adoption of the committee.

Mr. Dimayuga reported that for 2022, the RPMC will focus on the following: (a) preparation of quarterly RPMES monitoring reports; (b) conduct of RPMC meetings; (c) conduct of project monitoring visits or activities; (d) provision of trainings – engineering for non-engineers; (e) project facilitation; and (f) conduct of Local Project Monitoring Committee or LPMC summit.

The RPMC will also continue to run the engineering for nonengineers webinar series that provides technical assistance to the LPMCs, implementing agencies, state universities and colleges, and private sector representatives.

The Department of Public Works and Highways (DPWH), National Irrigation Administration (NIA), Department of Agriculture (DA), and the National Housing Authority (NHA) reported the status on the implementation of their major projects.

DPWH MIMAROPA reported that two of the proposed four bridges located in Mindoro Island Circumferential Road were already funded in 2022. While, the NIA MIMAROPA reported that they have conducted a validation of the memorandum of agreement and its ratification together with the Tagbanua Indigenous Cultural Community, and National Commission on Indigenous Peoples (NCIP).

The LPMCs of Oriental Mindoro, Occidental Mindoro, and Palawan also reported the functionality assessments of their local/city/municipal PMCs.

The meeting concluded with an agreement that all provincial/city PMCs should report on the functionality of their PMCs as regular agenda of the RPMC.




Figure 9. RPMC Meeting via Zoom on February 24, 2022.

IV. Trainings Conducted

A. Webinar Series on Engineering for Non-engineers: Roads and Bridges

The NEDA Regional Office (NRO) MIMAROPA conducted the webinar Engineering for Non-Engineers on March 22 and 23, 2022 through Zoom video conference. The training is a rerun of the first session of the webinar series focusing on roads and bridges construction.

It was attended by 99 participants, consisting of 51 men and 48 women, from various government agencies and organizations composed of five provinces, two cities, 26 municipalities, one state university, 11 non-government organizations, representatives from the Department of the Interior and Local Government (DILG) provincial offices, and staffs from NRO MIMAROPA.

In his opening message, NRO MIMAROPA Regional Director Agustin C. Mendoza welcomed the participants and emphasized the importance of being well-equipped, and in enhancing the quality of monitoring projects at the local level owing to the implementation of the Mandanas-Garcia Supreme Court ruling.

Mr. Roy A. Dimayuga, Engr. Amalia F. Santiago, Engr. Francis Bayani M. De Guzman, and Mr. Keizher T. Marasigan of the Project Monitoring and Evaluation Division served as resource speakers on the first day of the training. The topics covered monitoring and evaluation, planning, implementation, gender mainstreaming efforts, and organization of project monitoring committees.

Engr. Jakeson D. Alcones discussed the road classification, common equipment used including earth works such as embankment, base, and sub-base course involved in road construction, and erroneous practices.

On the second day, Engr. De Guzman continued the discussion on roads such as surface course, drainage and slope protection structures, and common defects and deficiencies. This was followed by a presentation on bridge construction and rehabilitation by Engr. Jojo Datinguinoo.

The participants were also provided with additional information on the use of Regional Project Monitoring and Evaluation System Forms 7 and 8, on the project inspection report and problem solving session or facilitation meetings conducted, respectively.

NRO MIMAROPA ARD Apollo Edwin S. Pagano, in his closing message, stressed the key lessons from the presentations and insights from the participants. He underscored that the valuable knowledge gained from the training is essential to achieve effective project monitoring and evaluation in the MIMAROPA region.
