This has reference to the memorandum sent on October 29, 2021, requesting your Gender and Development (GAD) Focal Point System (GFPS) or a team that you will authorize to accomplish the GAD Mechanisms Profiling and Inventory of GAD Policies Form.

The profiling and inventory tool was developed by the Regional Gender and Development Committee (RGADC) MIMAROPA to gather information on the preparation and submission of GAD plan and budget and GAD accomplishment reports, formulation of GAD code/agenda, establishment of GFPS, development of GAD database, and adoption and implementation of GAD policies of the agencies, local government units, state universities and colleges and other government instrumentalities, and assess the GAD mainstreaming efforts in the region.

The Regional Development Council (RDC) passed RDC Resolution No. 2021-075-997, approving and adopting the profiling and inventory form and enjoining all government instrumentalities in MIMAROPA to accomplish and submit the form to RGADC MIMAROPA (please refer to attached resolution).
