

A total of four hundred twenty (420) participants are expected to actively join physically in this activity to be held at the AFP Commissioned Officers' Clubhouse, Camp Aguinaldo, Quezon City, on 16 November 2022 from 8:00am to 3:00pm. The objectives of the National Summit are the following discussions:

2. Discuss the framework for the fulfillment of the 13 (thirteen) economic drivers affecting the national government agencies, public and private sector, investors/proponent's vis-a-vis the framework of the ICCs/IPs 11 Building Blocks.
