FY 2023 PLENARY BUDGET DELIBERATION IN THE SENATE**

DATE: November 09, 2022

In line with the upcoming Plenary Budget Deliberation on 16 November 2022, please be informed that the authorized attendees are required to present their **vaccination cards** (must have at least completed the primary dose series) and a negative result of a Reverse Transcription-Polymerase Chain Reaction (RT-PCR) test **taken within the last 72 hours** or an Antigen test **taken within the last 72 hours** as well. The RT-PCR/Antigen test should be done by a Department of Health (DOH)-accredited laboratory using a Food and Drug Administration (FDA)-certified testing kit.

Relative thereto, the DENR Central Office will conduct the Antigen testing for the Central Office attendees (**see attached Annex A**) of the budget hearing, details are as follows:

However, the expenses for the conduct of the Antigen testing for the Bureaus and Attached Agencies shall be charged to the funds of their respective offices.
