



PERMANENT RELEASE OF ONE (1) UNIT ISUZU ELF REF. VAN TRUCK (CLOSED VAN) WITH PLATE NUMBER PIV-825 AND CONFISCATION OF FIFTY-ONE (51) SACKS OF WOOD CHARCOAL APPREHENDED AT CALAPAN PIER, BRGY. SAN ANTONIO, CALAPAN CITY, ORIENTAL MINDORO

Records show that on August 12, 2016, at around 8:00 in the evening, the elements of Philippine National Police (PNP) of Oriental Mindoro Police Provincial Office, Provincial Intelligence, Branch, Bray Sudpit Calapan City apprehenced one (1) mint IS IZ WELFRET, Van truck (Closed Van) with Plate Number Provincial City apprehenced one (1) mint IS IZ WELFRET, Van truck (Closed Van) with Plate Number Provincial City one (2) safety of the Subject Conveyance and forest Pier, Bray San Antonio Calapan City Oriental, Vindoro Intersubject Conveyance and forest products have an estimated an arket value of PhP240,000,00 and PhP 7650,00, respectively, and were hauled and deposited at line PENRO Calapan City, Oriental Mindoro compound for safekeeping. The Seizure Receipt and Seizure Order both dated August 16, 2016 were issued by Forester III Domingo B. Santos, Seizure/Hearing Officer.

In the Pinagsamang Sinumpaang Salaysay dated August 15, 2016 of SPO1 Rolan P. Reanzares and PO1 Mark Arlan C. Punay with assignment at Oriental Mindoro Police Provincial Office-Provincial Intelligence Branch (ORMINPPO-PIB), they narrated that they received information from a concerned citizen that there is a one (1) unit vehicle with Plate Number PIV-825 loaded with wood charcoal. On August 12, 2016, at around 8:00 in the evening, they saw the conveyance in front of Calapan Bayside Hotel, Brgy. San Antonio, Calapan City. They followed the vehicle until it reached the Port of Calapan City. They identified Mr. Allan O. Noynay, driver and the passengers namely: Mrs. Gemma G. Tadeo, Mrs. Melanie Ma. Estaris, and Mr. Nikko Kyle Tidor who were regarding such load. It was disclosed that the conveyance was loaded with wood charcoal without permit from the DENR. Thereafter, they brought the conveyance to the PENR Office, Brgy. Suqui, Calapan City, for further investigation.

Pursuant to Section 7 of DAO 97-32, administrative hearings were conducted on August 16 and 18, 2016 at the DENR-PENR Office, Brgy. Suqui, Calapan City, Oriental Mindoro, which was presided by For. III Domingo B. Santos, Hearing Officer.

In the first hearing, Mrs. Gemma R. Tadeo claimed ownership of the forty (40) sacks of wood charcoal which were apprehended by the PNP of Oriental Mindoro Police Provincial Office on August 12, 2016. She admitted that the subject forest products had no permit to transport from the DENR. However, she presented a Barangay Certification issued by Barangay Chairman Roberto A. De Ocampo of Barangay Dulangan II, Baco, Oriental Mindoro, certifying that the Mahogany and Rambutan trees were planted in a titled property of Mr. Jose Valdez y Yoey of So. Sintala of the said barangay. The said trees were blown/felled during typhoon Nona that hit the province sometime in December 2015 and were manufactured by Mr. Valdez into charcoal. The charcoal were sold to her and Mrs. Melanie Estaris on June 12, 2016.

Mrs. Melanie Manlangit Estaris admitted that she owned the remaining eleven (11) sacks of wood charcoal loaded in the apprehended conveyance, and corroborated the statement of Mrs. Gemma R. Tadeo.

Mr. Nikko Kyle Tidor said that he was hired as helper of Mr. Allan O. Noynay (driver). Accordingly, his job is to follow instructions from the driver and passengers/owners of the cargoes. Further, the shippers told him that the subject forest products have a corresponding Barangay Certification.

Mr. Allan O. Noynay admitted that he was the driver of the ISUZU Elf Ref. Vanitruck (closed van) with plate number PIV-825 loaded with fifty-one (51) sacks of wood charcoal apprehended at the Calapan City Pier, Calapan, Oriental Mindoro. He stated that the owner of the said conveyance is Ms. Mary Grace Leonardo Dimagan of So. San Isidro, Cainta, Rizal, who was not aware of the use of the subject conveyance to transport wood charcoal without permit from the DENR. Further, Mr. Noynay claimed that the shippers (Mesdames Tadeo and Estaris) informed him that they have the necessary transport documents. However, they did not give him any copy thereof, accordingly, it was left in Brgy. Dulangan II, Baco, Oriental Mindoro.

The second hearing was conducted on August 18, 2016, which was attended by Mrs. Edna L. Dimagan, registered owner of the subject conveyance, who voluntarily submitted herself for oral questioning at the PENR Office, Calapan City, Oriental Mindoro. She presented and submitted to the Hearing Officer her proof of ownership of the apprehended vehicle, such as: Certificate of Registration, Official Receipt, and Deed of Sale of Motor Vehicle from Mary Grace Leonardo Dimagan, Vendor, During the hearing, Mrs. Dimagan vehemently denied any knowledge in the transport of wood charcoal using her cargo truck. She averred that her driver (Mr. Noynay) loaded issued by different concerned agencies to serve as proof that she is a legitimate businesswoman, as operator of a trucking services called "Judy and Edna Trucking Services", engaged in the shipment of various goods/merchandise.

On November 22, 2016, For. Domingo B. Santos, Hearing Officer, issued a Temporary Release Order of the subject conveyance, after available evidences were established that the conveyance may be used for lawful purposes, such as, but not limited to: personal mode of transportation; commercial passenger transport; cargo hauling, or other similar legal use, and upon payment of cash bond in the amount of three hundred thousand pesos (PhP300,000.00), pursuant to Section 9 of DAO No. 97-32 by the registered owner (Mrs. Edna L. Dimagan).

The Apprehending Police Officers filed the criminal complaint before the Regional Trial Court (RTC) Branch 39, with Criminal Case No. CR-17-13, 661 against the accused namely: Gemma Ronquillo Tadeo, Allan Noynay y Obanil and Melanie Estaris y Manlangit for violation of Section 77 of PD No. 705, as amended:

On November 10, 2017, Judge Edralin C. Reyes of Regional Trial Court (RTC) Branch 39, issued a Decision that sentenced Mrs. Tadeo and Mr. Noynay to a crime of Simple Theft with penalty of imprisonment ranging from two (2) years and four (4) months of prision correccional, as minimum, to six (6) years of prision correccional, as maximum, and to pay the costs of the suit. A Warrant of Arrest was also issued against the accused Melanie M. Estairs, who is at large.

After a thorough evaluation of the attending facts and circumstances, Mrs. Edna L. Dimagan was able to prove that she did not have full knowledge in the commission of the offense, pursuant to Section 7 (3) (b) of DAO 1997-32. Thus, this Office finds no reason to continue to hold the Cash Bond which was posted as a requirement for the temporary release of the subject conveyance.

This Office concurs with the recommendation of the Hearing Officer CENRO Socorro and PENRO Oriental Mindoro for the confiscation of the forest products in favor of the government.

WHEREFORE, FOREGOING PREMISES CONSIDERED, the apprehended fifty-one (51) sacks of wood charcoal with an estimated fair market value of PhP 7,650.00 are hereby CONFISCATED in favor of the government to be disposed of in accordance with the existing DENR laws, rules, and regulations. The one (1) unit ISUZU EIF Ref. Van truck (Closed Van) with Plate Number PIV-825 is hereby PERMANENTLY RELEASED to its rightful owner, Mrs. Edna L. Dimagan including the RETJIRN of the Cash Bond filed in connection therewith.
