**CELEBRATION ON 6 DECEMBER 2022**

The Alternative Dispute Resolution (ADR) Committee has been setting strategies in place to improve ADROs' performance in providing ADR Services. One activity that began in 2020 was the awarding of Best ADR Officers and Best Regional Pool of ADROs (PADRO) to honor productivity, efficiency, and effectiveness in delivering ADR services, as well as contributions to the institutionalization of ADR in the Department.

The award, which will be granted to accredited ADROs and Regional PADROs, aligns with the Department's PRAISE Program and the Civil Service Commission's order<sup>1</sup> to foster creativity, innovation, efficiency, integrity, and productivity in public service.

Using the ADR-Monitoring and Results System (ADR-MRS), the ADR Committee was able to select the shortlisted nominees for the award this year. The shortlist of nominees for the award was collected using data such as the total number of cases referred for ADR, the number of ADR procedures held, the number of cases with successful ADR processes, and the number of cases issued with an Order of Compromise or Settlement Agreement.

To validate the data and determine the contribution of an individual ADRO and the Regional PADRO to the institutionalization of ADR, the ADR Committee Secretariat will conduct a Validation Interview for the following nominees on the following dates through video conference or in-person interview:
