*Greetings from the National Nutrition Council – MIMAROPA!*

The Philippine Multi-Sectoral Nutrition Program aims to support the government in adopting a bold, multi-sectoral nutrition approach to deliver a coordinated package of nutrition-specific and nutrition-sensitive interventions across various LGUs together with a harmonized social behavior change and communication strategy. The project will prioritize LGUs with the highest burden of childhood stunting based on the best available data. Primary project beneficiaries will comprise children under five years old (with attention to children under two years who will be reached by project activities before stunting becomes largely irreversible), as well as pregnant and lactating women in LGUs, prioritized for PMNP support. There are fourteen (14) identified target areas in the MIMAROPA Region; seven (7) LGUs in Occidental Mindoro and seven (7) LGUs in Romblon.


