“WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions, local government units shall promote health and safety;

“WHEREAS, Bulalacao, a 3rd class municipality with a population of 44,366 based on 2020 census that has a tropical climate situated at approximately 12° 12' North, 121° 21' East, it has municipal government that promotes proper utilization of forest land, river, marine and coastal resources;

“WHEREAS, the Local Government of Bulalacao is pursuing to have an Agro-Forestry Program in the municipality to provide assistance for the development and maintenance of the forest-based farming such as the woody perennials (forest and fruit trees) and agricultural crops (rice and vegetables) products;

“WHEREAS, the implementation of the Agro-Forestry Program in Bulalacao would help majority of the more than 6,000 individuals who are employed in the agricultural sector in the said municipality, thus, it would need support from higher agencies for its total implementation; Now, therefore, be it...




