ACCREDITATION OF ALTERNATIVE DISPUTE RESOLUTION OFFICERS (ADROs) FROM BATCHES 13-14

and

CONFIRMATION AS THIRD-PARTY NEUTRALS IN THE DEPARTMENT

WHEREAS, in accordance with Republic Act No. 9285, the ADR Law of 2004, Executive Order No. 523 and DENR Administrative Order (DAO) No. 2016-30, the DENR has institutionalized Alternative Dispute Resolution (ADR) mechanism as a means of resolving land disputes, claims and conflicts on land disposition before the Department;

WHEREAS, pursuant to Section 6, Chapter 3 of DAO No. 2016-30, the ADR Committee was created to institutionalize and supervise the implementation of ADR in the Department including the design and implementation of training program for prospective ADR Officers (ADROs) as well as the evaluation of the ADR program and performance of ADROs;

WHEREAS, Section 7 of DAO 2016-30 mandates the creation of a Pool of ADR Officers (ADROs) to be evaluated and accredited by the ADR Committee;

WHEREAS, Section 9 of DAO 2016-30 further mandates that no personnel shall be accredited unless he/she completes the appropriate training prescribed by the ADR Committee;

WHEREAS, the Training Module for prospective ADROs is in compliance with R.A. No. 9285 and its Implementing Rules and Regulations implemented by the Office for Alternative Dispute Resolution Office of the Department of Justice (OADR-DOJ), and the accreditation and training standards of ADR practitioners and service providers;

WHEREAS, pursuant to the requirements of the OADR-DOJ under Department Circular No. 49 series of 2012, the ADR Committee conducted two batches of ADR Basic Skills Training and Practicum/Internship Training that were facilitated by the Conflict Resolution Group (CoRe Group), an accredited training provider of OADR-DOJ with Training Module approved by the said office and tailored to the training needs of the Department.

WHEREAS, Section 10 of the OADR-DOJ Department Circular No. 49 series of 2012 provides that the accreditation is mandatory for ADR practitioners offering ADR services to government agencies or in partnership of said agencies, and government agencies shall only partner with or engage the services of the OADR-accredited ADR practitioners;

WHEREAS, pursuant to the Certificates of Completion issued by the the CoRe Group, the following prospective ADROS have successfully completed the 80-hour ADR Training Course (Basic Training and Practicum/Internship), and passed the assessment (written examination and practicum);

BE IT FURTHER RESOLVED, that the ADROs can now discharge the authority vested to them, and must observe at all times the highest standards of integrity,

competence, impartiality, diligence and probity in their conduct and provision of ADR services in the Department.

The ADROs are hereby designated as *Accredited ADR Officers* of the Department as defined under Section 4(a) and institutionalized under Section 7 of DAO 2016-30.

RESOLVED FINALLY, that the accredited ADROs of the Department be **CONFIRMED** by the Hon. Secretary Maria Antonia Yulo Loyzaga, vesting them the authority to provide ADR services and act as third-party neutral in the Department.
