The MIMAROPA Regional Development Council will be conducting a virtual consultation workshop on the formulation of MIMAROPA Regional Development Investment Program (RDIP) 2023-2028, Public Investment Program (PIP) 2023-2028, and agency regional office (ARO) Three-Year Rolling Infrastructure Program (TRIP) for FYs 2024-2026 as input to the FY 2024 Budget Preparation.
