08-12 November 2022 | Coron, Palawan

### **1. Schedule and Venue**

The consultation and planning workshop will be held on **08 - 12 November 2022** (inclusive of travel time) at **Coron Westown Resort, Coron, Palawan**. All participants are expected to be at the venue on or before the workshop proper.
