

CHEEY, BUSUANGA AND RGY. TAGUMPAY, CORON, PALAWAN BY THE DPWH- DEO- I CORON AND CONTRACTED TO ONE HUNDRED PERCENT (OHP) DEVELOPMENT AND CORP.

In compliance with unwritten re: above subject, please be informed that the undersigned forest officers conducted posting of Billboard for Tree Cutting Clearance/Permit (TCP) on conspicuous areas for the widening project of DPWH-OHP.

On October 4, 2022, the undersigned forest officers together with Barangay Officials of Barangay Cheey and Barangay Tagumpay and representative Engineers from DPWH-DEO-O Coron and Engineer of One Hundred Percent Development and Corporation (OHP) conducted site inspection and posting of billboard on the on-going road widening project at Barangay Cheey, Busuanga and Barangay Tagumpay, Coron, Palawan.

Furthermore, during the on-site inspection, the team noticed that the contractor has already commenced the leveling off of the existing road surface as the initial phase of the operation activity of the road widening.

The team advice the Field Foreman OHP and Field Engineer not to uproot the trees marked with numbers during the time of inventory and avoid the same until such time that the clearances/permit is already been granted and approved to them.


Recommendation:

It is hereby recommended that the DPWH-Coron and One Hundred Percent Development and Corporation adhere to replace 10,000 endemic juvenile seedlings for Memorandum Order No. 2012-02 Series of November 5, 2012 also known as "Uniform Replacement Ration for Cut or Related Trees"
