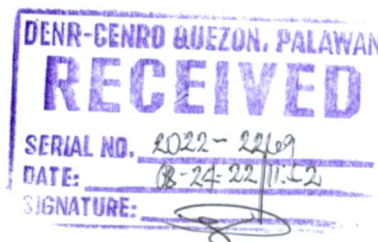

Respectfully submitted is the report on the conducted site validation/ ground inspection on the mangrove cutting at Sitio Manduros, Barangay Panalingaan, Dr. Jose P. Rizal, Palawan.

Please be informed that the multi-sectoral team together with the SIBAT and BPATS of Barangay Panalingaan proceeded at Sitio Manduros, Panalingaan, Rizal, Palawan at exactly 8:27 a.m. During the ground validation the following activities were conducted by the team:

1. Coordinated with the tenants of the area that the team will be having a meeting and will conduct ocular inspection of the claimed area of the identified actual claimant/occupant;
2. Conducted ocular inspection, geotagged the extent of occupation and boundaries of respective claimant/ occupant and gathered gps reading;
3. Meeting with the community regarding the proposed sustainable livelihood that will fit on the area such as: mud crab fattening and seaweeds farming.

MENRO Jenel Joy C. Torres also reminded the community to report immediately when they observed individuals who conduct illegal charcoal making in the area. The team also remind them that this kind of activity is a violation of P.D 705 and R.A 11038 or the Expanded National Integrated Protected Area System Act (ENIPAS) of 2018.

Moreover, the team conducted reconnaissance survey of the area and it was observed that there's continuous mangrove charcoal making in the same area. The team recorded 3 pile of poles with 300 pieces in total number and 7 sacks of charcoal.

Furthermore, the team will continuously conduct the once a week monitoring and patrolling together with the multisectoral team to closely monitor the area for further actions to be taken regarding this illegal activities. Attached are the geotagged photos and attendance during the conduct of the activity.
