SUBJECT : REQUEST TO UPDATE “NO STATUS” CASES IN THE
ADR-MRS

Pursuant to Section 11 of DENR Memorandum Circular (DMC) 2021-03, the ADR Committee shall carry out activity to promote the use of the ADR-MRS as a platform to enhance, expedite or streamline the methods of recording data and gathering of results of the ADR in the conduct of ADR processes implemented in the Department.

The ADR Monitoring and Results System (ADR-MRS) shall serve as the official, automated, web-based, and real-time platform for recording of data, status, and results of claims and conflict cases and other disputes. It is a tool designed for the ADR Officers and authorized Third-Party Neutrals to input basic data of the cases subjected to ADR process.

As part of our institutionalization of ADR and implementation of ADR-MRS in the Department, we require that all cases must be updated in the ADR-MRS with the correct and updated information. As of October 2022, there are 217 cases having “no status” in the ADR-MRS.
