

IAC RESOLUTION NO. 01 - 2022

A RESOLUTION CANCELLING THE NOTICE OF AWARD (NOA) GRANTED TO THE FOLLOWING PROPONENTS OF THE RIVER RESTORATION THROUGH LARGE-SCALE DREDGING ACTIVITIES IN THE PROVINCE OF ORIENTAL MINDORO: 1. ALL ASIA-RESOURCES RECLAMATION CORPORATION; 2. EON BULK HANDLING SERVICES INC., JOINT VENTURE WITH Z2K RESOURCES, INC.; 3. FJORD OCEANIC CORPORATION IN PARTNERSHIP WITH KELE BUILT CORPORATION; 4. GC8 KINMING; 5. STURDY CONSTRUCTION AND DEVELOPMENT CORPORATION; 6. KAIRO KONSTRAK, INC. JOINT VENTURE WITH YSK HOLDINGS INC; AND 7. VIBRANIUM LAND DEVELOPMENT AND TECHNOLOGY OPC, JOINT VENTURE WITH SUNWEST CONSTRUCTION AND DEVELOPMENT CORPORATION

WHEREAS, DENR-DPWH-DILG-DOTr Joint Memorandum Circular No. 01, Series of 2019 (JMC 1-2019) provides for the "Guidelines on the Issuance of Clearance and/or Permit for Dredging Within Waterways or Other Inland Bodies of Water" as the primary basis to promote the flood control efforts of the State;

WHEREAS, in accordance with the mandate of DENR Department Administrative Order No. 14, Series of 2019 (DAO 14-2019), the Inter-Agency Committee (IAC) shall propose policies and programs to rationalize the dredging operations in the Province of Oriental Mindoro;

WHEREAS, the IAC had initially identified six (6) major river systems to be subject of the River Restoration Project through dredging activities, namely: (1) Bongabong River, (2) Bucayao River (3) *Mag-Asawang Tubig* River, (4) Balete River, (5) Alag River; and (6) Longos River;

WHEREAS, on 03 January 2022, the Secretariat sent letters to the above mentioned nine (9) proponents to submit their respective Pre-Feasibility Study; Dredging Methodology and Program of Works for the rivers assigned to them within one (1) month from receipt thereof;

WHEREAS, for failure to submit the required documents under JMC 1-2019 and DAO 14-2019, the Inter-Agency Committee hereby recommends the cancellation of the Notice of Award of the following: 1. All Asia-Resources Reclamation Corporation; 2. Eon Bulk Handling Services Inc., Joint Venture with Z2k Resources, Inc.; 3. Fjord Oceanic Corporation in Partnership with Kele Built Corporation; 4. GC8 Kinming; 5. Sturdy Construction and Development Corporation; 6. Kairo Konstrak, Inc. Joint Venture with YSK Holdings Inc; and 7. Vibranium Land Development and Technology Opc, Joint Venture with Sunwest Construction and Development Corporation;

NOW THEREFORE, BE IT RESOLVED, that the IAC cancels the Notice of Award of the following proponents:

1. All Asia-Resources Reclamation Corporation;
2. Eon Bulk Handling Services Inc., Joint Venture with Z2k Resources, Inc.;
3. Fjord Oceanic Corporation in Partnership with Kele Built Corporation;
4. GC8 Kinming;
5. Sturdy Construction and Development Corporation;
6. Kairo Konstrak, Inc. Joint Venture with YSK Holdings Inc; and

7. Vibranium Land Development and Technology Opc, Joint Venture with Sunwest Construction and Development Corporation

FURTHER RESOLVED, that the Provincial Government of Oriental Mindoro, through the Financial Working and Technical Working Group for River Restoration and Dredging Activities shall be allowed to accept anew Letters of Intent and Proof of Financial and Technical Capacities of interested applicants.

IAC RESOLUTION NO. 02 - 2022

A RESOLUTION APPROVING THE SCHEDULE OF ACTIVITIES FOR ACCEPTANCE OF APPLICANTS FOR THE CONDUCT OF RIVER RESTORATIO THROUGH LARGE-SCALE DREDGING ACTIVITIES IN THE PROVINCE OF ORENTAL MINDORO

WHEREAS, DENR-DPWH-DILG-DOTr Joint Memorandum Circular No. 01, Series of 2019 (JMC 1-2019) provides for the “Guidelines on the Issuance of Clearance and/or Permit for Dredging Within Waterways or Other Inland Bodies of Water” as the primary basis to promote the flood control efforts of the State;

WHEREAS, in accordance with the mandate of DENR Department Administrative Order No. 14, Series of 2019 (DAO 14-2019), the Inter-Agency Committee (IAC) shall propose policies and programs to rationalize the dredging operations in the Province of Oriental Mindoro;

WHEREAS, to streamline the processing of the documents submitted by applicants who intend to conduct river restoration through large-scale dredging activities in the Province of Oriental Mindoro, the IAC hereby approves the schedule of activities for acceptance of documents for pre-qualification;

NOW THEREFORE, BE IT RESOLVED, that the schedule of activities for pre-qualification of applicants and a listing of documents required are hereby approved:

1. Posting of Notice	Notice of Invitation to applicants posted in conspicuous places in all Local Government Units in the Province of Oriental Mindoro	Period of Compliance: October 17- November 7, 2022
2.Submission of Financial and Technical Capabilities (Pre-Feasibility Study)	A. Financial Capacity: Individual Applicants – not less than not less than P250,000,000.00 in asset value through the submission of an Audited Financial Statement, credit lines and/or income tax returns for the preceding three (3) years and other documents that may be required by the concerned DENR agency. Corporation, Partnership, Association or a Consortium - capital must be at least sixty per centum (60%) owned by citizens of the Philippines with a minimum authorized capital stock of One Billion Pesos (P 1,000,000,000.00), twenty-five percent (25%) of which is subscribed and twenty-five percent (25%) of that subscribed is paid up. In no case shall the paid up capital be less than P250,000,000.00. For consortiums, one of its members must possess these qualifications.	Period of Compliance: November 7 - December 7, 2022

Technical Capacity:</p> <p>Only applicants capable of large-scale dredging activities for flood mitigation or prevention purposes in the heavily-silted river channels within the Province of Oriental Mindoro, based on their technical knowledge and verifiable previous track record conducting such activities, as properly vetted, duly certified and approved by the appropriate DENR and DPWH offices.</p>
