As per our memorandum dated October 10, 2022 Re: requests recommendations in the eFIS. We would like to reiterate our response to item 1. **"The Area field of the eFIS is designed to accept at least 1 square meter or 0.0001 hectares which is more than enough to record backyard tree plantations."** Based on our observation of the provided sample of the issued Private Tree Plantation Registration (PTPR) we would like to clarify if the unit of measure used (**sq. m**) in the declaration of the Private Tree Plantation Lot Area with planted 100 trees of Mahogany is correct or missed declared. Moreover, we would also request a copy of the GIS Generated Map of the Tree Plantation to verify the Area of the private tree plantation.
