

POLICY CONSULTATION WORKSHOP ON VARIOUS POLICY PROPOSALS UNDER THE FORESTRY SECTOR

19 to 21 October 2022 | Linden Suites
Ortigas, Pasig, Metro Manila

I. Rationale

The Forest Management Bureau is mandated to provide technical guidance to the DENR Central and field offices in the effective protection, development, and conservation of forestlands and watersheds, and to recommend policies and programs towards the achievement of sustainable forest management, based on science and principles of good forest governance.

As part of this mandate and to ensure the participation of the DENR Field Offices in the policy development process, the Policy Consultation Workshop on Various Policy Proposals under the Forestry Sector shall be spearheaded by the Forest Management Bureau on 19 to 21 October 2022 in Metro Manila.

II. Objectives and Expected Output

The Policy Consultation Workshop aims to solicit inputs and recommendations from the DENR Regional Offices on the following draft policy proposals under the forestry sector:

1. Draft Administrative Order (DAO) re: Revised Rules and Regulations Governing the Retrieval of Trees, Tree Stumps, Tops, and Branches Damaged by Natural Hazards
2. DAO re: Revocation of DAO No. 2018-09 and Addendum to DAO No. 2003-24 or the Implementing Rules and Regulations of the Chainsaw Act of 2002
3. Draft DAO re: Guidelines on the Process of Verification and Issuance of Certification of Land Classification Status Relative to the Implementation of the Support to Parcelization of Lands for Individual Titling (SPLIT) Project
4. Draft DENR Memorandum Circular (DMC) re: Guidelines on the Integration and Standardization of Forestry Spatial Datasets (FSD)
5. Draft DMC re: Guidelines on the Inventory of Structures in Forestlands
6. Draft DENR Memorandum Order (DMO) re: Revised Guidelines on the Uniform Replacement Ratio and Modes of Replacement for Cut, Removed, and/or Relocated Trees

The policy consultation workshop shall result to the final working draft of the abovementioned guidelines for the review and endorsement of the FMB Policy Review Committee, the DENR Policy Technical Working Group, and concerned Undersecretaries prior to the consideration and approval of the Secretary.
