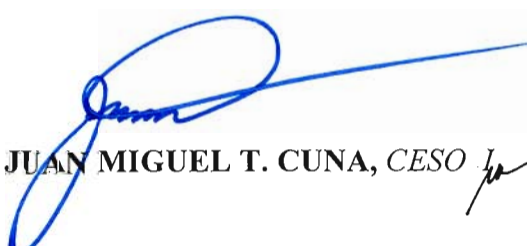

#### **Peer review**

PAP operates a double-blind peer review model. All submitted papers undergo an initial assessment by the journal editors. If they are considered suitable for peer review, they will then be reviewed by a minimum of two external reviewers to assess their suitability for publication. Final responsibility for editorial decisions rests with the Editor-in-Chief.

#### **Open access**

All articles in PAP are published in Open Access under a CC BY 4.0 licence.

#### **Publishing Services partnership**

PAP is published by Emerald Publishing on behalf of the Hong Kong Public Administration Association and SPEED, The Hong Kong Polytechnic University. PAP is published under a platinum OA arrangement, in that all charges for publishing an OA article in PAP are funded by the Hong Kong Public Administration Association and SPEED, The Hong Kong Polytechnic University.
