MOTION TO RECALL THE COMPLAINT

This refers to the attached Motion to Release Impounded Vehicle and Urgent Motion to Recall the Complaint dated 10 June 2021 filed by Mr. Nelson Amores, owner's representative of the vehicle, to this Office on 23 June 2021.

The said Motion is relative to the seizure of one (1) Isuzu Dump Truck with plate number CCO5956 by the technical personnel of the Community Environment and Natural Resources Office (CENRO) – Brooke's Point. Per DENR Administrative Order (DAO) No. 2018-18, "the DENR RED, Assistant Regional Director for Technical, PENROs and CENROs are authorized to arrest offenders and confiscate/seize illegally-sourced mineral/mineral products and the tools, equipment and conveyance used in the commission of illegal mining" pursuant to Section 1181 of DAO No. 2010-21.

This Office is, therefore, requesting you to evaluate the Motion in accordance with existing policies since the seizure was undertaken by your Office.

Basis of Arrests and Confiscations/Seizures. xxx The Bureau officers which include the Regional Director and other Bureau personnel, duly authorized by the Director, DENR personnel duly authorized by the Secretary, Permittee, Contractor, Permit Holder and other duly deputized personnel shall have the authority to arrest offenders, and confiscate/seize iflegally-
