SUBJECT : **REQUEST FOR APPROVAL ON THE MODIFICATION/
CHANGE OF OBJECT EXPENDITURE WITHIN
ALLOTMENT CLASS – CAPITAL OUTLAY**

This has reference with the procurement of one (1) unit Single Phase Distribution Transformer intended for CENRO Puerto Princesa. A Sub-Allotment Advice amounting to One Hundred Twenty Five Thousand Pesos (Php 125,000.00) was downloaded last July 13, 2022 per SAA No. CO-R4B-101-2022-07-697.

Last April 2022, the supply of electricity of CENRO PPC was unstable until it lost its power line and as an option, they used the generator set for over a month. Upon consultation and inspection of PALECO, the electric provider here in Palawan, it is inefficient to repair or restore the old Transformer so they recommended to replace it with a brand new one to ensure efficient power supply of the office. Hence the request for funding for the procurement of a brand new 50 KVA Transformer has been made.


Since the need was urgent and important, and cannot wait until the approval of their request for funding, CENRO PPC decided to use the funds intended for the repair and maintenance of the motor vehicle detailed in their office.

In view of this, may we respectfully request that the allotment downloaded for the procurement of a brand new Transformer be modified and used for the replacement of a new Engine for the motor vehicle/pick-up, Ford Ranger Trekker 2.5L 4x2.


JUSTIFICATION

The CENRO Puerto Princesa lost its power line connection for over a month due to loose at the secondary bushing of the old distribution transformer as indicated in the Test Report and needed for servicing/baking. However, upon consultation, only 70-80% capacity might be restored after baking and may not be able to sustain the load capacity (present and additional) of the office. We requested for the urgent replacement/procurement of a brand new 50 kVA distribution transformer to ensure efficient power supply and can cater additional load in the office.

Since the funds were not available at that time, the office used the funds for the repair and maintenance of vehicle to address the urgency of the matter.

Thus, the allotment for the procurement of a brand new single phase distribution transformer is requested to be used for the purpose of repair and maintenance of vehicle as replacement for the fund used.



