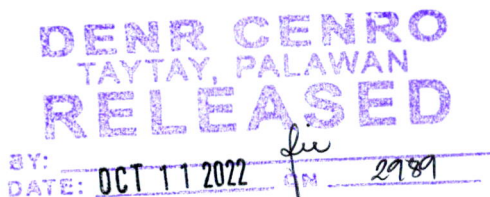

This pertains to the Memorandum of the then DENR Secretary Roy A Cimatu dated May 1, 2020 entitled "*Lifting of Suspension of the Transportation of All Forest Products and Wildlife by Land, Sea or Air throughout the Country, Pursuant to Republic Act No. 11469 or the "Bayanihan To Heal as One Act"*". Pursuant to said Memorandum all Regional Executive Directors are instructed to accept, process and issue transport-related permits or documents for all forest products and wildlife being issued by the DENR.

Further, under said Memorandum forest products to be transported that needs Certificate of Timber Origin/Certificate of Lumber Origin (CTO/CLO) pursuant to DAO No. 1994-07 and DAO No. 2007-31 shall be allowed even in the absence of confirmation from FMB. However, since the issuance of said Memorandum, this Office has not yet received any reports pertaining to the issued CTO/CLO by the DENR field offices.

Relative thereto, may we request the immediate submission of reports covering the period of May 1, 2020 onwards consistent to the provisions of DENR Administrative Order No. 07 dated February 17, 1994, i.e. the DENR field officials who issued CTO/CLO shall make and submit a monthly reports and copies of the used Certificate of Origin Forms (COFs) to the Undersecretary for Field Operations, through the Forest Management Bureau (FMB) using the attached template for monitoring and updating of database.
