Greetings!

ACX3 Capital Holdings, Inc. ("ACX3") is a Philippine holding corporation engaged in the development, operation, and maintenance of renewable energy projects in the Philippines. ACX3 is a subsidiary of NEXIF Energy, an independent developer and manager of power and infrastructure projects in South and Southeast Asia.

ACX3 presently has equity interests in two (2) solar PV projects in Calabanga, Camarines Sur and Bacolod City, Negros Occidental aggregating to 224 MWp. In addition, in August 2021, ACX3 was awarded five (5) Wind Energy Service Contracts ("WESCs") by the Department of Energy ("DOE") for the exclusive right to explore, develop, and utilize offshore wind energy within certain areas off the coast of Luzon ("Contract Areas").

ACX3 holds two (2) WESCs in Region V (i.e., San Miguel Bay Wind Power Project (500 MW) and Camia Bay Wind Power Project (500 MW) in Camarines Sur), two (2) WESCs in Region IV-A (i.e., Lucena Wind Power Project (475 MW) and Tayabas Bay Wind Power Project (275 MW) in Quezon), and one (1) WESC in Region IV-B (i.e., Lubang & Looc Wind Power Project (600 MW) in Occidental Mindoro) (collectively, the "**Projects**"). All the Projects are presently in the pre-development stage.

As you may be aware, the DOE is presently undertaking an offshore wind roadmap study and consultation process with various relevant government agencies (including the Department of Environment and Natural Resources - Regional Office IVB) which will result in the development of detailed guidelines for offshore wind development in the Philippines. These guidelines, inter-alia, are expected to set out in detail the development and permitting process for offshore wind developers during the pre-development and development stages



and are also expected to address key development aspects such as possessory rights at various stages of project development.

However, the release of the final guidelines by the DOE is only expected to be complete in 2023. In the interim, ACX3 intends to continue with the pre-development activities of the Projects and seeks your assistance for the same to ensure that the development of the Projects will not be challenged by other offshore activities. We humbly request your good office to please inform ACX3 of any present and future claims by third parties, including prior licenses, permits, or agreements issued, and applications submitted, to conduct any activity on areas which overlap with the Contract Areas for the Projects.

We have attached the maps with the technical description of the Contract Areas and details of the Projects as **Annex "A"**, for your reference.
