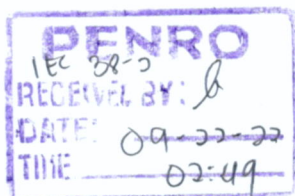

Pursuant to Presidential Proclamation No. 470, Series of 2003, the 2022 International Coastal Clean-Up day on September 17, 2022 with the theme "Fighting for Trash Free Seas-Pilipinas: Ending the Flow of Trash at the Source" was celebrated in Sta. Cruz, Occidental Mindoro.

This office spearheaded the conduct of coastal clean-up in partnership with Local Government Unit of Sta. Cruz, along the coast line of Brgys. Poblacion Uno, Poblacion Dos and Mulawin in Sta. Cruz on September 17, 2022. The activity started at 6:30 in the morning after the brief orientation at Municipal gymnasium and ended with a short program at Poblacion Dos covered court.

Mayor Ernesto P. Torreliza and Vice Mayor Mark P. Galsim, who both attended the clean-up expressed their gratitude for the DENR for carrying out the activity in their town and committed to support any endeavour of CENRO Sablayan.

The CENR Officer acknowledged the support of the LGU and participation of other agencies. In his speech he emphasized the importance of such activities in the environment. "It is to make people aware that everyone must act to protect our only home, because if we don't, then who will? If not now, then when?" he said. "I hope that the unity we have shown today will be the beginning of our partnership towards the protection of the environment", he added.

At the end of the program, everyone gathered for the photo documentation. A certificate of appreciation was given to the participants for their support and participation in the said activity.

In addition, the Local Government Unit of Sablayan and Paluan also spearheaded the same activity within their coastal Barangays. The clean-up in Sablayan was attended by the personnel of APO Reef - Protected Area Management Office (PAMO) while in Paluan, it was attended by the Mt. Calavite Wildlife Sanctuary – PAMO personnel
