Active collaboration and involvement of forest communities and other stakeholders in forest protection and law enforcement for CY 2022, please be informed that this Office conducted orientation of candidates for deputation as Environment and Natural Resource Officer (DENRO) on September 22, 2022 at the PENRO Conference Hall Barangay Bangbangalon, Boac Marinduque.

The said training was attended by selected representatives from Philippine National Police, Provincial Government Environment and Natural Resource Office.

The Three (3) Resource Speakers in the said event are; Forester Don Gibson D. Mercado, In-Charge Monitoring and Enforcement Section, Engr. Cynthia U. Lozano, Chief Technical Services Division and Prosecutor Dioscoro P. Timtiman Jr., Deputy Provincial Prosecutor.

The topic discussed during the orientation are the following: The Environmental and Natural Resources policy (Presidential Decree No. 705 otherwise known as Revised Forestry Code of the Philippines, EO 23 (Declaring Moratorium on the cutting/harvesting of trees in the natural residual forest & creation of the Anti-Illegal Logging Task Force), EO 26 (National Greening Program), EO 277 (Amended Sec 68 of PD 705, mere possession of undocumented forest products, with the offense of Qualified Theft or illegal logging), RA 7161 (Forest Charges, & Prohibits Cutting of all Mangrove Tree Species), RA 9175 (Chainsaw Act of 2002 : requiring permit prior to import, distribute, manufacture, sell/retail, own, possess & use of chainsaw), DAO 97-32 1997 Rules for the Administrative Adjudication of Illegal Forest Products and the Machinery, Equipment, Tools and Conveyances Used in Connection therewith, Republic Act No. 9147 otherwise known as "Wildlife Resources Conservation and Protection Act, Salient features, Fines and Penalties".

Prosecutor Matimtiman discussed the topics on Filing of Environmental Cases, Judicial Affidavit Rule A.M. No. 12-8-8-SC, Sworn Attestation of the Lawyer, who are qualified to be witness, what evidence may be admitted, 3 types of evidence, how to introduce documentary and confiscated object evidence.

The third topic discussed is the DENR Administrative Order No. 2008-22 which focused on Functions and Duties of DENRO/SDENRO, Qualifications of individual/s and groups for deputation, Requirements for application of DENRO.

On to the last part of the program, Engr. Cynthia U. Lozano, Chief Technical Services Division rendered her closing message and acknowledgement to all the Resource Speakers for sharing their time and efforts, she also genuinely thanks everyone who participated the said activity.
