 - 6.2 Stand and Stock Table
 - 6.3 Tree Charting Map
 - 6.4 Geo-tagged photographs
- Certification from the CENRO concerned stating that the applied area for SIFMA does not overlap with other tenure or reforestation programs of the government (e.g., National Greening Program)
