With the implementation of the LAWIN Forest and Biodiversity Protection System, respectfully submitted is the detailed report of the Busuanga Pasture Reserve Management Office (BPRMO) on the results of the Lawin monitoring and patrolling activity conducted in the Municipalities of Coron and Busuanga, Palawan within the BPR area for the month of September 2022.

### T. **Findings and Result**

Two (2) Patrol Teams were dispatched during the conduct of this activity within the Forest Conservation Area (FCA) of BPR situated in the Municipalities of Coron and Busuanga, Palawan. The target distance for the month of September 2022 is 30 kilometers (km) based on the Lawin Patrol Plan for the 3rd Quarter of 2022. On the said month, the BPRMO Patrol Teams were able to traverse an aggregate distance of 32.21 km or 107.37 % (Table 1).

\*The accomplishment rate is computed based on the 30 kilometer target per CENRO/CA per month compared to the sum of the distance patrolled per CENRO/CA.

Table 2 shows a total of 473 Forest Condition Counts (FCCs) recorded during the patrolling. Early Secondary Forest (ESF) appears to have the highest figure recorded for September 2022 with 255 counts or 54%, while Old Growth Forest (OGF) has the least recorded observation with 9 counts or 2%. The remaining forest conditions such as Open-Cultivated (OC), Advanced Secondary Forest (ASF), and Open-Uncultivated (OUC) with

corresponding total figures of 83 (18%), 55 (12%), and 71 (15%), respectively. Based on the SMART analysis, the total FC with the good condition has a total count of 319 or 67.44% which includes OGF, ASF, and ESF.

For the presence of natural regenerants, 341 FCCs or 72.09% of the total FCC was recorded with the presence of natural regenerants while 132 FCCs or 28% were with the absence of natural regenerants. There were five (5) or 1% recorded dense natural regenerants, while one hundred seventeen (117) FCCs or 25% and two hundred nineteen (219) or 46% recorded as moderate and sparse natural regenerants, respectively (Table 3).

Table 4 shows the observed and recorded threats within the FCA of BPR. A total of six (6) threats were observed and recorded during the Lawin Patrolling for the month of September 2022 and this was accounted for four (4) under tree cutting; one (1) for huts or houses and other infrastructures; and lastly one (1) for slash and burn farming (kaingin).

As can be viewed from the map in Annex C, the threats observed/documented in the FCA during the month of September 2022 were found in Barangays of Quezon, Cheey, and New Busuanga, Busuanga and Brgy. Decalachao, Coron to Brgy. Sto. Niño, Busuanga, Palawan. The current threat index was computed as 0.12 threats per kilometer (T/Km) in January 2022, up to 0.21 T/Km in the month of March 2022, down to 0.03 T/km in April 2022 up to 0.26 T/Km for the month of June. The highest recorded was 0.40 T/km for the month of July, down to 0.06 on August and increased to 0.19 on September 2022. On the other hand, there are no threats recorded in the month of February 2022 and May 2022.

# II. Actions Taken by the BPRMO for the observed threats

Pertaining to the six (6) observed/recorded threats for the month of September, the BPRMO sent communication letters dated September 14, 2022, addressed to the Barangays of Quezon, Cheey, and New Busuanga, Busuanga for information regarding the conducted LAWIN patrolling and monitoring within their area of jurisdiction. Furthermore, as a follow-up action, this office also sent a coordination letter dated September 16, 2022, to Brgy. Bintuan, Coron and Brgy. Quezon, Busuanga for the conduct of Information and Education Campaign (IEC).

# III. Remarks and Recommendations

- Frequency of the visibility of patrolling and LAWIN monitoring within the Forest Conservation Area of BPR is being intensified to include weekends, if necessary, in order to prevent and immediately address any possible threats within the forested areas of BPR;
- To send communication letter address to the Barangay for the conduct of followthrough action of the BPRMO personnel with a record of threats observed in every conduct of LAWIN patrolling and monitoring to inform and assists them if it requires urgent action;
- Observed unlawful activities on the ground are being thoroughly investigated and documented and filing of appropriate criminal complaints against the offenders pursuant to Presidential Decree No. 705 of 1975 as amended and other environmental laws, if so warrant;
- 4. Conduct of seminar/IEC to every barangay recorded with a high incidence of unlawful activities within the area covered by the BPR to provide awareness and educate the community on the importance of maintaining ecological and environmental balance in the locality and the benefits that could be derived from the forest and climate change mitigation; and
- 5. Conduct of rehabilitation activities such as tree planting, enrichment planting and assisted natural regeneration to maintain and accelerate the recovery of forest cover.




# Trends of Observations per Patrol Kilometer in the Forest Conservation Area

### **Trend in Threats**





### **Trend in Indicator Species**




An increasing trend in indicator species in the forest conservation area means effective forest protection; a decreasing trend means the opposite.


# Trends in Regeneration Density








# Locations and urgency of responses needed

Furnishing you herewith is the report pertains to the implementation of Lawin Forest and Biodiversity Protection System conducted by the Technical Staff and Office Support Staff/Bantay Gubat of BPR Management Office on September 13, 2022 within the Forest Conservation Area (FCA) of Busuanga Pasture Reserve specifically in Barangays of Quezon, Cheey and New Busuanga, Palawan.

Report disclosed that during the Lawin activity, the patrollers encountered a total of five (5) threats. Patrollers recorded three (3) threats under tree cutting; one (1) for huts or houses and other infrastructures; and lastly one (1) for slash and burn farming (kaingin) within patrol route.

In line with this, please be informed that the recorded illegal activities in the said reservation violates certain laws and regulations of the DENR such as:

 Presidential Proclamation 1387 issued on 1975 – Reserving and establishing as a Pasture Reserve a certain parcel of land of the public domain situated in the island of Busuanga, Province of Palawan

> Whereas, do hereby withdraw from sale, lease, settlement or any other form of disposition, exploration or exploitation, and reserve as a pasture reserve, subject to private rights.

 Section 77 of Presidential Decree 705 as amended (Revised Forestry Code of the Philippines) - Cutting, Gathering and/or collecting Timber, or Other Forest Products Without License



This pertains to the apprehension of one (1) unit of chainsaw on April 12, 2022, at So. Lili Buton, Brgy. San Rafael, Busuanga, Palawan by the personnel of BPRMO, reported to the office thru memorandum dated April 13, 2022. In connection to the mentioned apprehension the OIC, Assistant Regional Director for Technical Services instructed thru the PENR Officer-DENR-PENRO Palawan with the attention to the OIC, CENRO Coron for submission of the Administrative Adjudication Proceedings with categorical recommendation including pertinent documents pursuant to DAO-97-32 to serve basis for further action.

In compliance to the said instruction, please be informed that the DENR-CENRO Coron together with the BPRMO personnel will be conducting an Administrative Adjudication for the said incident based on the DENR Administrative Order 97-32 of 1997 Rules for the Administrative Adjudication of Illegal Forest Products and the Machinery, Equipment, Tools, and Conveyances Used.

In reference to the letter dated August 8, 2022, informing the DSWD that one of the persons involved, as offender on this matter is Mr. Junnel Edonga, a resident of Brgy. San Rafael, Busuanga, Palawan and found to be minor. The offenders violated Section 77 of P.D. 705, as amended and Section 4 of R.A. 9175 or the Chainsaw Act of 2022. The CENRO Coron already sent a letter dated July 4, 2022 to the parents of Mr. Edonga informing them the involvement of their son.

On that note, may we request a representative from the DSWD Busuanga for the conduct of Administrative Adjudication in Face to face platform that will be facilitated by the DENR-CENRO Coron and FMB BPR Management Office. This Office would like to seek assistance to your Office regarding the case of Mr. Edonga since he is a minor.
