**RESOLUTION ON THE MOBILIZATION OF THE FUND COMMITTEE OF THE SABANG  
BAY WATER QUALITY MANAGEMENT AREA (SB WQMA)**

**WHEREAS**, the Area Water Quality Management Fund is hereby established as stipulated in the Section 10 of the R.A. 9275 or the Philippine Clean Water Act of 2004 for the maintenance and upkeep of the Water Quality Management Area of Sabang Bay;

**WHEREAS**, the Area Water Quality Management Fund shall be sourced from the fees collected under the wastewater charge system established under Section 13 of the R.A. 9275 or the Philippine Clean Water Act of 2004 as well as donations, endowments and grants for the WQMA shall accrue to the fund;

**WHEREAS**, the funds for the Area Water Quality Management Fund (AWQMF) shall be directly deposited in a Modified Disbursement System (MDS) Account at the Landbank of the Philippines – Intramuros;

**WHEREAS**, Section 12.4 of the Governing Rules of Sabang Bay WQMA states the creation of Fund Committee chaired by the Department of Interior and Local Government (DILG) with the following member agencies: LGU-Puerto Galera – Office of the Accounting, Treasurer and Budget, National Economic Development Authority (NEDA), National Water Resources Board (NWRB), Provincial Government – Environment and Natural Resources Officer (PG-ENRO), Department of Trade and Industry (DTI) and Environmental Management Bureau (EMB).

**WHEREAS**, the Fund Committee, as stated in Section 14.2 of the Sabang Bay WQMA Governing Rules, shall establish an Administrative and Finance Group (AFG), which shall be responsible for the day-to-day management of the AWQMF subject to requirements under R.A. 9275 and DAO 2016-06. Furthermore, the AFG shall have the following members: LGU Puerto Galera Finance Committee (Accounting, Treasury, Budget and MPDC), LGU Puerto Galera Local Chief Executive and SB WQMA Governing Board Treasurer

**WHEREAS**, the AFG, as stated in Section 14.3 of the Sabang Bay WQMA Governing Rules, shall work closely with the Finance and Administrative Division of the EMB MIMAROPA with the following functions: (a) planning and budgeting; (b) accounting and financial reporting; (c) fund management; (d) fund raising support; and (e) administrative services

**NOW, THEREFORE**, for and in consideration of the foregoing, the SB WQMA Governing Board hereby **RESOLVES** as it is hereby **RESOLVED** to operationalize the Fund Committee of the Sabang Bay WQMA.
