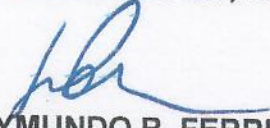

(for disasters with lead time for warning)

## IMPACT PHASE

Actions when the disaster has taken place  
(also for sudden onset disasters)

## POST-IMPACT PHASE

Actions after the emergency period  
(gradual return to normalcy)
