For FY 2023, the Department of Environment and Natural Resources will be rolling out the USAID SIBOL Activity - Green Assessment as one of its programs. It will be used to assess natural ecosystems and its services such as its condition, biodiversity, supply, and demand, etc., establish baseline data for different ecosystems, and formulate management recommendations for green resilience plans.

The green assessment consists of four (4) stages: 1) Rapid Appraisal, 2) Ground Validation Surveys, 3) Analysis and Interpretation, and 4) Green Resilience Planning. A series of workshops will be conducted to enhance the capacity of DENR employees through the updating of existing methodologies and the adoption of new ones for the department.

The rapid appraisal workshop will utilize Geographic Information System (GIS) and Remote Sensing (RS) technology to train employees of the department to properly generate and analyze satellite images along with primary and secondary data on land cover classification to identify areas of interest for the succeeding steps.
