27 July 2021	DENR requests BTr to transfer 58M to DENR Region IVB. (Region IVB will release the funds to the Provincial Government of Palawan for construction of Phase II of the Tubbataha Ranger Station)
1 Oct 2021	DENR requests PCG for records pertaining to the use of the PhP29.6M from the US, as required by the BTr
5 January 2022	PASu Angelique Songco requests President Duterte for help with release of 58M; PRRD Appointments Office endorsed the letter to BTr, DENR, and Office of the Executive Secretary on 7 Jan 2022
12 January 2022	BTr responds to PRRD Appts Office that Notice of Cash Allocation is being maintained by the NGA concerned, thus the BTr cannot issue a confirmation on the Php58M balances
15 Feb 2022	DENR requests DBM for issuance of Notice of Cash Allocation for the PhP58M
18 Feb 2022	DBM requires BTr Certification showing the requested amount was deposited in the account of DENR-OSEC-RO IVB-Proper
25 May 2022	TMO follow up with Mr. Jonathan Mercado, Accounts Analyst, BTr-NCAD, the issuance of Certification by BTr
26 May 2022	Mr. Mercado inquires after PCG response re use of its share in US payment
26 May 2022	TMO follow-up with PCG issuance of certification/report pertaining to its use of PhP29.6M
29 June 2022	TMO reports to 8888 hotline PCG inaction re the issuance of certification

01 July 2022	PCG issues the certification re its use of PhP29.6M
25 July 2022	TMO follow-up BTr re the issuance of certification required by DBM
