This refers to the email dated September 6, 2022, of Ms. Maria Abegail A. Albaladejo, Chief, Fisheries Planning and Economics Division (FPED), Bureau of Fisheries and Aquatic Resources, requesting for the list of salt producers in the country.

Pursuant to Section 5 of DENR Administrative Order (DAO) No. 1998-67¹, dated December 9, 1998, it was indicated that in the identification and declaration of potential Salt Production Area (SPA), "all CENROs shall identify areas suitable for existing salt production areas within public domain, and areas with natural/rock salt deposits". Likewise, a report shall be submitted which shall cover the actual area used, total leased area, optimum production volume per year, actual production volume, direct beneficiaries, tenurial status, and the awarding and expiry dates. Also, the conduct of monitoring and reporting of Salt Production Sharing Agreement (SPSA) is delegated to your end per Section 7 of the said DAO.

In view thereof, we are referring herewith the aforesaid email for further action. Please directly inform the party concerned of any action taken thereon, in accordance with existing laws, rules and regulations, copy furnished this Office for reference.
