Respectfully referred herein transmittal letter sent thru email dated 02 August 2022, from Dir. Jaime Llaguno Mabilin, Presidential Complaint Center (PCC) bearing Code No. **WG-AKA-08-02-2022-009**, forwarded to the Office of DENR Secretary thru the Head Executive Assistant, and further conveyed to the DENR Action Center/Hotline endorsing the letter of **Mr. Roberto Paredes** of Brgy. 3, Roxas, Palawan pertaining to his request for the issuance of title over their claimed parcels of land in Brgy. 3, Poblacion, Rozas, Palawan. Accordingly, they were already issued a survey authority over the subject lots while also have been paying its taxes for 14 years now, however, four (4) other survey authorities were allegedly issued in their area by CENR Officer Pablo Cruz of CENRO Roxas, thereby inhibiting the requesting party's title application. Hence, this merits your appropriate action, consistent with existing laws, rules and regulations.

Kindly inform directly the requesting party of action taken in this regard furnishing the PCC and this Office for monitoring/reference purposes. Expeditious action is requested in accordance with the provisions of Republic Act No. 11032, otherwise known as the Ease of Doing Business and Efficient Government Service Delivery Act of 2018 as implemented and enforced by the Anti-Red Tape Authority. Please be reminded that failure to timely respond to the public's concern shall be ground for administrative sanctions under existing laws and regulations.
