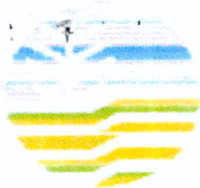
In this regard, we are hereby reiterating the request to higher level of authority for the conduct a formal investigation relative to the said administrative complaint.
