DENR-CENRO ANASTACIO SANTOS Location/Address: SABLAYAN, OCCIDENTAL MINDORO; DENR Red Felix Mirasol, Jr. Nais po naming ireklamo ang kawalan ng aksyon ni Ginoong Anastacio Santos ng DENR Sablayan Occidental Mindoro, hinggil sa aming naging reklamo tungkol sa illegal na pamamasok at pagsira ng kabundukan ng mga kasapi ng OMKADA sa aming lugar sa Sitio Lagdaan, Brgy. Tayamaan, Mamburao, Occidental Mindoro. Kami po ay nagtataka kung bakit hanggang ngayon ay hindi ipinatutupad ni Ginoong Anastacio Santos ang matagal ng memorandum galing po sa inyong opisina, mahigit halos 10 buwan na ang nakakalipas. Naimbestigahan na po ng PENRO Occidental Mindoro ang nasabing reklamo, at kanilang napatunayan ang katotohanan ng aming reklamo, kaya nga noon pong November 02, 2022 nagbaba po ng Memorandum From The Oic, Assistant Regional Director For Technical Services To: The OIC, PENR Officer Occidental Mindoro, na inuutusan ang CENRO-Sablayan na kasuhan ang mga nabanggit na taong namasok at sumira sa kagubatan. Kami po ay sobrang natuwa sa naging resulta, subalit kapalit po ng tuwa ay sobrang sama ng loob sapagkat pagkalipas ng halos 10 buwan, simula po noong November 02, 2022 hanggang ngayong August 31, 2023 ay wala pa ring ginagawang aksyon si Ginoong Anastacio Santos ng CENRO sablayan, tuwing meeting po ay kami pa ang napapagalitan at patuloy niyang kinakampihan ang mga taong namasok at sumira sa kagubatan sa aming lugar. At kami pa na lehitimong taga Lagdaan na syang tumanda na sa aming lugar ang siyang gustong alisan ng karapatan ni Ginoong Anastacio Santos. Sinasabi din po ni Ginoong Anastacio Santos na tanging sya lamang ang masusunod kung ano ang gagawin at hindi nya kailangang sumunod sa kahit na sino. Sya daw ang magsasabi kung kanino nya ibibigay ang kagubatan. Sobra pong arogante ni Ginoong Anastacio Santos, hindi po kami makapagsalita dahil palagi nya kaming binabara at pinapakita na sya ay galit at mainit ang ulo. Hindi po dapat ganito ang opisyal sa amin. Ang lahat po ng kanyang ginagawa at sinasabi sa amin ay pawang pagkukunwari, at panlilinlang. Palagi po nyang sinasabi na pantay pantay ang lahat sa kanya, na ang batas ay para sa lahat, subalit hindi po ito totoo, palagi po nya kaming inililigaw. Kaya nga kahit may utos na sa kanya ang mas mataas sa kanya ay binabalewala nya. Mayroon din pong nakapagsabi sa amin na naging tauhan ni Ginoong Anastacio Santos sa kanyang Sibuyasan o bukid ang ibang tao na kasamahang pinakakasuhan, kaya pala palagi nyang kinakampihan. pinahihinog pa daw ang papel. Kaya po hanggang ngayon ay hindi nya inaaksyunan ang Memorandum ng OIC, Assistant Regional Director. Ang Memorandum po ay naglalaman po ng mga sumusunod; SUBJECT: COMPLETED STAFF WORK (CSW) REPORT RE: FOREST DESTRUCTION AND ILLEGAL OCCUPANCY AT SITIO LAGDAAN, BRGY. TAYAMAAN, MAMBURAO OCCIDENTAL MINDORO. (P-2022-96906) DATE: NOV 02, 2022 This is to acknowledge receipt of your Memorandum dated October 13, 2022 submitting the investigation Report dated October 11, 2022 of CENRO-Sablayan relative to the forest destruction and illegal occupancy at Sitio Lagdaan, Brgy. Tayamaan, Mamburao Occidental Mindoro. Based on the report, a total of 1.346 hectares were affected by the illegal cutting and clearing operations facilitated by members of the Occidental Mindoro Kadiwa Agricultural and Development Association (OMKADA), who occupied the area since 2020. Accordingly, the forested portion of the timberland were subdivided by members of the association for cultivation. In line with this, you are hereby directed to advise CENRO-Sablayan to prepare case build up against the members of OMKADA for Violation of Sec. 78 (formerly Sec. 69) of P.D 705, as amended (Unlawful Occupation or Destruction of Forest Lands.) Likewise, the CENRO concerned is also instructed to intensify their LAWIN patrolling activities, in coordination with the LGU, to avoid the occurrence of similar incident. Submit report of your action/s taken within five (5) working days upon receipt hereof for monitoring purposes. Signed MAXIMO C.
