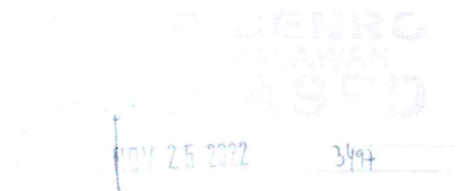

Greetings!

We respectfully acknowledged the receipt of your letter dated November 16, 2023 sent via electronic email yesterday. It is a request for a). Certification on the status of the reclaimed area in Poblacion, Taytay, Palawan with the land classification status of the adjacent inland, and b) request for Survey Authority over the same reclaimed land for purposes of processes to issuance of Presidential Proclamation and Titling pursuant to PRA Administrative Order 2021-01 and DENR Administrative Order 2018-14.

Please rest assured that we are committed to working with on the matter. In fact, the determination of the status and land classification of the adjacent inland is now on-going verification, projection and research. As to the request for Survey Authority, a representative of this Office had already made a round of inspection in the area.

This concern is, however, new to us for now and the undersigned has yet to seek the guidance and instruction of the DENR MIMAROPA Regional Executive Director considering the provisions under DAO 2018-14 wherein it is implied that the Composite Team pursuant to its Section 7 was already formed wherein a representative only of this Office shall be a member.

We shall also inquire as to requirement or not in the project of Environmental Impact Assessment, Environmental Compliance Certificate and Area Clearance insofar as Section 21 of the DAO is concerned considering that the area was already reclaimed.

We shall inform you as soon as possible once we received instructions from our higher authorities.

We trust to have appropriately responded on your concern and thank you.
