RESOLUTION REQUESTING THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR)- MIMAROPA REGIONAL OFFICE SURVEYS AND MAPPING DIVISION TO EXPEDITE THE APPROVAL OF SURVEY PLANS FOR TWO COLLECTIVE CERTIFICATE OF LAND OWNERSHIP AWARDS (CLOAS) UNDER THE MINDORO STATE UNIVERSITY (MINSU) COVERED BY THE COMPREHENSIVE AGRARIAN REFORM PROGRAM PER EXECUTIVE ORDER NO. 75

WHEREAS, 1,045.1314 hectare- portions of the MinSu located at Barangay Alcate, Victoria, Oriental Mindoro, formerly known as Mindoro State College of Agriculture and Technology (MinSCAT), had been previously declared as alienable and disposable lands by virtue of Presidential Proclamation No. 260;

WHEREAS, the said portions had an Approved Survey Plan (ASP) and eventually distributed to qualified beneficiaries in 1992;

WHEREAS, two Collective Certificates of Land Ownership Awards (CCLOAs) covered by EO 75 of the subject landholding with a total area of 346 hectares had been subsequently distributed in January 17, 2022;

WHEREAS, Engr. Jovito Cadatal consequently conducted the land survey of another two Collective CLOAs of said property but reported that its survey return was handed back by the DENR allegedly claiming it is unclassified forest land
