## **ASec Gilbert C. Gonzales**

- The Assistant Secretary welcomed and started a roll call of the participants from Regions 1-8, NCR, CAR, and Bureaus.
- He advised the REDs, RDs and ARDs that cluster meeting is held in preparation for the National Management Conference scheduled on 12 April 2023. Primarily, the meeting aims to consolidate the issues per region and filter the most important ones. ASec Gonzales also outline the agenda of the meeting:

Difficulty Securing Certified Copies of Titles from LRA to resolve Land Matter Cases	Certified copies of titles from LRA costs 400 to 500 per title, which are being shouldered personally by lawyers from the CAR Legal Division. LRA opined the DENRCO to execute MOA with LRA, to provide DENR with certified copies free of charge.  Regarding the MOA with LRA on data linking and sharing, LMB responded that the API testing is already being done this quarter. Part of this system is the certification of the status of land to avoid double titling and survey. Application of Provincial Government of Pangasinan expanding their proclaimed area under Proclamation 1258	The Provincial Government of Pangasinan aims to expand its land area up to 300 ha. for mixed use and industrial park. The area is within Proclamation 156 (Lingayen Gulf), so they are also requesting for a special patent issued in their favor. At present, the status of land is unclassified public land. DENR-1 recommends ocular inspection and site assessment with FMB and NAMRIA to determine the appropriate tenurial instrument for the said land.  LMB has performed an ocular visit last January 2023, but the report is yet to be read by Dir. Talabis. Nevertheless, she noted that expanding up to 300 ha. entails a lot of work, including determining the viability of the area and assessment of their proposed projects, especially since they have not utilized their existing 184 ha. DPWH-R5 incurred a substantial number of backlogs for the period 2019-2022 because they are having a difficult time complying with tree replacement project due to absence of specific guidelines. Demand letters were already sent by DENR-5 to different offices of DPWH for compliance of their backlogs. The regional office recommends FMB to initiate a high-level discussion with DPWH and to immediately come up with specific guidelines.  As per seedling replacement, FMB responded that they already submitted to PTWG the revision or amendment for seedling replacement guidelines. But then, they are still awaiting schedule for the deliberation. In terms of the maintenance and protection of tree plantings, FMB suggests to oblige tree cutting permittees since planting, maintenance, and protection are part of the TOR of their cutting permit.  As a final note, Atty. Sopsop voiced out his concern about the policies that are still pending with PTWG and whether there is a way to fast track these policies to avoid backlogs.
