This pertains to the recently conducted subgroup meeting on FPIC, tenure instruments and enforcement conducted on 14 March 2023 at the Forest Management Bureau attended by representatives from DENR MGB, NCIP and DENR Regions NCR, CAR, 1, 2, 3, 4A,4B, 10, 11 and 13.

Among the Agreements in the meeting is to replicate the initiatives from Regions 1 and 10 who initially forged their local partnership agreements with the NCIP. DENR Region 1 have submitted their draft Memorandum of Understanding (MOU) with their NCIP counterparts. The said MOU also included their respective provincial Joint Operational Agreements (JOA) which detailed the specifics of each party's responsibilities. On the other hand, DENR Region 10, has already conducted a series of mapshops with DENR, DAR, NCIP & AFP within the Region. This was made possible through their regular Regional Development Council meetings. The resulting map overlay shows the overlapping areas between forest related programs, permits, licenses and CADT/CALC in shapefile format using PRS 1992 projection. The identified regional counterparts of each national government agency were required to prepare their respective authoritative maps as their primary input to the mapshop. Here are the required thematic maps for AFP, DAR, and NCIP.

• AFP: Military Reservation Areas

• DAR : approved CLOA Areas

NCIP: CADC and CADT Areas

As part of the initial preparation for the said regional mapshop and consistent with the standards prescribed in submitting spatial datasets, shapefiles of the following is requested to be prepared as our main input, to wit:

- Land Classification (Forestland, Alienable & Disposable, Natural Park);
- Protected Areas;
- Tenurial Instrument (Tenured Areas), attached is a list of sample;
- Protection and Production Forest:
- Potential Areas for Investment; and
- Cadastral Lots
